The listed activity relevant at the time of activity commencement is Activity 9 of the EIA Regulations, GN R.1182, published in terms of the Environment Conservation Act, 1989 (Act 73 of 1989).

Golder Associates (now a member of WSP) has been appointed as the independent environmental assessment practitioner (EAP) to undertake the Section 24G regularisation process.
