I-New Largo ifaka isicelo selayisensi yokusebenzisa amanzi (i-WULA) eMnyangweni Wezamanzi Nokuthuthwa Kwendle, ngokweSigaba 41 soMthetho Wamanzi Kazwelonke, 1998 (uMthetho No. 36 ka-1998) (NWA) sokusebenzisa amanzi njengoba kuchaziwe Isigaba 21 se-NWA. I-GN R.267 ibeka ukuthi i-WULA kufanele isekelwe Uhlelo Oludidiyelwe Lokulawulwa Kwamanzi Nemfucuza (IWWMP) kanye nohlu lwezifundo zobuchwepheshe ezifana namaxhaphozi nezinye izifundo zochwepheshe ezihlobene nemvelo.
