ACCEPTANCE OF THE FINAL SCOPING REPORT FOR THE PROPOSED UP TO 837MW PHEFUMULA EMOYENI ONE WIND ENERGY FACILITY (WEF) NEAR ERMELO WITHIN THE MSUKALIGWA LOCAL MUNICIPALITY IN THE MPUMALANGA PROVINCE

The Application for Environmental Authorisation and Final Scoping Report (FSR) received by the Department on 30 May 2024, refer.

The Department has noted that the entire development study area is located within the Amersfoort-Bethal-Carolina Important Bird Area (SA018). You are advised in terms of Regulation 8(b) of the EIA Regulations 2014 as amended, that the location of the wind energy development within a high avifaunal sensitivity area may prejudice the success of this application.

This letter serves to inform you that the following information must be included in the final EIAr:

(a) Specific comments

- The Amersfoort-Bethal-Carolina IBA hosts globally and regionally threatened species that are not found (i) in similar abundance in other provinces. Several species are at risk of becoming extinct, some of which have be found at the proposed site (e.g., regionally threatened African Marsh Harrier (Endangered), Blue Crane (Near Threatened), Denham's Bustard (Vulnerable) and Cape Vulture (Endangered)). The threat of the proposed development to the IBA and the current status of globally threatened bird species such as the Botha's lark is of a concern. The Department urges the EAP and the applicant to evaluate whether the proposed development is suitable for this area considering the high avifaunal sensitivity.
- (ii) It is evident that large tracts of natural habitat in the study area, particularly in the south, are delineated as CBA Irreplaceable (CBA 1). These areas are required to meet biodiversity targets for biodiversity pattern (species and ecosystems) and ecological processes. Particularly, part of the development area is affected by intact grassland patches that are considered "source" areas for avifaunal species. These areas should remain in a natural state that is maintained in good ecological condition and therefore must be excluded from the development footprint.

- (iii) Further investigation into a possible offset agreement with the provincial competent authority required to reduce the ecological impacts of the development must be submitted with the draft EIAr. The agreement must also be submitted to this Department's Biodiversity Section for comments.
- (iv) The development area is located within areas with a high prominence of wetlands (including natural pans) and with very high aquatic/freshwater biodiversity significance that may be important for flamingos and other water-dependent birds.
- (v) It is further noted that there may be competing mining rights within the development area. The EIA must exclude these areas from the development footprint.
- (vi) Overall, this Department urges the EAP and the applicant to evaluate whether the proposed development is suitable for this area considering the significant threat to Critical Biodiversity Areas, intact grassland patches, Important Bird Areas and the habitat of numerous threatened bird species. The anticipated impacts on biodiversity, particularly the avifauna, is too great to support this project. A more thorough ecological assessment and exploration of alternative locations are crucial before proceeding with this project.

(b) Listed Activities

- (i) The EIAr must provide an assessment of the impacts and mitigation measures for each of the listed activities applied for.
- (ii) The listed activities represented in the EIAr and the application form must be the same and correct.
- (iii) The EIAr must assess the correct sub-listed activity for each listed activity applied for.

(c) Public Participation

- (i) Please ensure the language used to inform potential I&APs in the newspaper advertisement is not only communicated in the language English but should also utilise other dominant languages spoken in the study area. The EAP must ensure that the newspaper medium adequately caters for all potential I&APs in the study area. This should also apply to any site notification boards as well.
- (ii) Please ensure that comments from all relevant stakeholders are submitted to the Department with the EIAr. This includes but is not limited to the Mpumalanga Department of Agriculture, Rural Development, Land and Environmental Affairs (DARDLEA), the Mpumalanga Tourism & Parks Agency, the Msukaligwa Local Municipality, the Gert Sibande District Municipality, the Department of Water and Sanitation (DWS), the South African Heritage Resources Agency (SAHRA), the Endangered Wildlife Trust (EWT), BirdLife SA, the Department of Mineral Resources, the Department of Forestry, Fisheries and the Environment: Directorate Biodiversity and Conservation, and the Directorate Protected Areas.
- (iii) Please ensure that all issues raised and comments received during the circulation of the draft SR and draft EIAr from registered I&APs and organs of state which have jurisdiction in respect of the proposed activity are adequately addressed in the final EIAr. Proof of correspondence with the various stakeholders must be included in the final EIAr. Should you be unable to obtain comments, proof should be submitted to the Department of the attempts that were made to obtain comments.
- (iv) A Comments and Response trail report (C&R) must be submitted with the final EIAr. The C&R report must incorporate all comments for this development. The C&R report must be a separate document from the main report and the format must be in the table format as indicated in Appendix 1 of this comments letter. Please refrain from summarising comments made by I&APs. All comments from I&APs must be copied verbatim and responded to clearly. Please note that a response such as "noted" is not regarded as an adequate response to I&AP's comments.
- (v) Comments from I&APs must not be split and arranged into categories. Comments from each submission must be responded to individually.
- (vi) The Public Participation Process must be conducted in terms of Regulation 39, 40, 41, 42, 43 & 44 of the EIA Regulations, 2014, as amended.

(vii) Minutes and attendance registers (where applicable) of any physical/virtual meetings held by the Environmental Assessment Practitioner (EAP) with Interested and Affected Parties (I&APs) and other role players must be included in the final EIAr.

(d) Layout & Sensitivity Maps

- (i) The EIAr must provide coordinate points for the proposed development site and all proposed infrastructure (note that if the site has numerous bend points, at each bend point coordinates must be provided) as well as the start, middle and end point of all linear activities.
- (ii) All preferred turbine positions must be clearly numbered. The turbine position numbers must be consistently used in all maps to be included in the reports and the specialist studies.
- (iii) The EIAr must provide a copy of the final preferred layout map. All available biodiversity information must be used in the finalisation of the layout map. Existing infrastructure must be used as far as possible e.g., roads. The layout map must indicate the following:
 - a) A clear indication of the envisioned area for the proposed wind energy facility;
 - b) Position of the wind turbines;
 - c) Powerlines;
 - d) Internal roads;
 - e) All supporting onsite infrastructure such as laydown area, guard house and control room etc.;
 - f) Substations, transformers, switching stations and inverters;
 - g) Battery Energy Storage System;
 - h) The location of sensitive environmental features on site e.g. CBAs, heritage sites, wetlands, drainage lines etc. that will be affected by the facilities and its associated infrastructure;
 - i) Connection routes (including pylon positions) to the distribution/transmission network;
 - j) All existing infrastructure on the site, especially railway lines and roads; and
 - k) Buildings, including accommodation.
- (iv) Please provide an environmental sensitivity map which indicates the following:
 - a) The location of sensitive environmental features identified on site, e.g. CBAs, protected areas, IBAs, heritage sites, wetlands, drainage lines, nest and roosting sites, etc. that will be affected by the facility and its associated infrastructure;
 - b) Buffer areas; and
 - c) All "no-go" areas.
- (v) The above layout map must be superimposed (overlain) with the sensitivity map and a cumulative map which shows neighbouring and existing infrastructure.
- (vi) Google maps will not be accepted.

(e) Specialist assessments

- (i) The EAP must ensure that the terms of reference for all the identified specialist studies must include the following:
 - a) A detailed description of the study's methodology; indication of the locations and descriptions of the development footprint, and all other associated infrastructures that they have assessed and are recommending for authorisation.
 - b) Provide a detailed description of all limitations to the studies. All specialist studies must be conducted in the right season and providing that as a limitation will not be allowed.
 - c) Please note that the Department considers a 'no-go' area, as an area where no development of any infrastructure is allowed; therefore, no development of associated infrastructure including access roads is allowed in the 'no-go' areas.
 - d) Should the specialist definition of 'no-go' area differ from the Department's definition; this must be clearly indicated. The specialist must also indicate the 'no-go' area's buffer if applicable.

- e) All specialist studies must be final, and provide detailed/practical mitigation measures for the preferred alternative and recommendations, and must not recommend further studies to be completed post EA.
- f) Bird and bat specialist studies must have comments from Birdlife South Africa and SABAA.
- g) Should a specialist recommend specific mitigation measures, these must be clearly indicated.
- (ii) Should the appointed specialists specify contradicting recommendations, the EAP must clearly indicate the most reasonable recommendation and substantiate this with defendable reasons; and were necessary, include further expertise advice.
- (iii) It is further brought to your attention that Procedures for the Assessment and Minimum Criteria for Reporting in identified Environmental Themes in terms of Sections 24(5)(a) and (h) and 44 of the National Environmental Management Act, 1998, when applying for Environmental Authorisation, which were promulgated in Government Notice No. 320 of 20 March 2020 (i.e. "the Protocols") and in Government Notice No. 1150 of 30 October 2020 (i.e. protocols for terrestrial plant and animal species), have come into effect. Please note that specialist assessments must be conducted in accordance with these protocols.
- (iv) Please also ensure that the EIAr includes the Site Verification Report and Compliance Statements (where applicable) as required by the relevant themes.
- (v) Please note further that the protocols, if applicable, require certain specialists' to be SACNASP registered in the field of expertise of the specialist study being undertaken e.g. An aquatic assessment must be prepared by a specialist registered with SACNASP, with expertise in the field of aquatics sciences. Please ensure that the relevant specialist certificates are attached to the relevant reports.
- (vi) <u>As such, the Specialist Declaration of Interest forms must also indicate the scientific organisation</u> registration/member number and status of registration/membership for each specialist.
- (vii) The following Specialist Assessments will form part of the EIAr:
 - Agriculture Impact Assessment;
 - Aquatic Biodiversity Impact Assessment ;
 - Avifauna Impact Assessment ;
 - Bats Impact Assessment;
 - Heritage Impact Assessment;
 - Noise Impact Assessment;
 - > Terrestrial Biodiversity Impact Assessment;
 - Visual Impact Assessment;
 - Socio-Economic Impact Assessment;
 - Traffic Impact Assessment;
 - Geotechnical Assessment;
- (viii) Please ensure that each specialist study has the correct and same project description and layout to assess.
- (ix) Please include a table that shows the proposed studies and the relevant specialists carrying out the study. In addition, a summary should be included of the specialist's recommendations in terms of the alternatives that are preferred based on the findings of their study.

(f) Cumulative Assessment

- (i) A cumulative impact assessment for all identified and assessed impacts must be conducted to indicate the following:
 - a) Identified cumulative impacts must be clearly defined, and where possible the size of the identified impact must be quantified and indicated, i.e., hectares of cumulatively transformed land.
 - b) Detailed process flow and proof must be provided, to indicate how the specialist's recommendations, mitigation measures and conclusions from the various similar developments in the area were taken into consideration in the assessment of cumulative impacts and when the conclusion and mitigation measures were drafted for this project.

- c) The cumulative impacts significance rating must also inform the need and desirability of the proposed development.
- d) A cumulative impact environmental statement on whether the proposed development must proceed.

(g) <u>General</u>

- (i) The EIAr must provide the technical details for the proposed facility in a table format as well as their description and/or dimensions. A sample for the minimum information required is listed under Annexure 2 below.
- (ii) The EAP must provide landowner consent for all farm portions affected by the proposed project i.e., all farm portions where the access road, wind turbines and associated infrastructure are to be located.
- (iii) A construction and operational phase EMPr that includes mitigation and monitoring measures must be submitted with the final EIAr, including the Generic EMPr for substations.

The applicant is hereby reminded to comply with the requirements of Regulation 45 of GN R982 of 04 December 2014, as amendment, with regard to the time period allowed for complying with the requirements of the Regulations.

You are hereby reminded of Section 24F of the National Environmental Management Act, Act No. 107 of 1998, as amended, that no activity may commence prior to an environmental authorisation being granted by the Department.





COMMENTS ON THE DRAFT SCOPING REPORT FOR THE PROPOSED UP TO 837MW PHEFUMULA EMOYENI ONE WIND ENERGY FACILITY (WEF) NEAR ERMELO WITHIN THE MSUKALIGWA LOCAL MUNICIPALITY IN THE MPUMALANGA PROVINCE

The Application for Environmental Authorisation and the draft Scoping Report (SR) dated April 2024 and received by the Department on 15 April 2024, refer.

This letter serves to inform you that the following information must be included to the final Scoping Report:

(a) Specific Comments

- (i) The layout plan submitted in the final SR must reflect all turbine positions (turbines to be numbered), substations, BESS, roads, operation and maintenance building, construction camp laydown area, and all associated infrastructure. The co-ordinates must be specific to each activity and infrastructure that is proposed on the site. The co-ordinates for the turbines, substations and the battery energy storage systems must be included in the report.
- (ii) Kindly ensure the development footprints (hectares/square metres) and specifications of all proposed infrastructure and associated infrastructure during all phases are included in the final SR. We require that you provide us with the specific development footprints for each development parameter, and not an area outlining the entire site.
- (iii) Please ensure that the application form, the SR and all the Terms of Reference (TOR) for the specialist studies and all subsequent reports submitted to the Department have similar project descriptions; including the electricity output and their TOR must be in line with the proposed layout plan.
- (iv) The screening tool indicates that seventeen (17) specialist assessments need to be undertaken or conducted. Only thirteen (13) specialist reports are planned to be done. Kindly take note that it is the responsibility of the EAP to familiarise yourself with the contents and requirements of the protocols and ensure compliance thereof.

- (v) Please ensure that a site sensitivity verification report that complies with Part A of the protocols is submitted with the final SR and addresses the following:
 - a) A verification using desktop analysis and details of the site inspection;
 - b) Site sensitivity for each theme/study listed, as well as compliance statements for assessments not needed to be conducted based on your site sensitivity verification.
 - c) The outcomes of the verification which clearly confirms or disputes the current use of the land and environmental sensitivity as identified by the screening tool; and,
 - d) Contains motivation and evidence of the either verified or different use of the land and environmental sensitivity.
- (vi) Please note further that the protocols, if applicable, require certain specialists' to be SACNASP registered. Please ensure that the relevant specialist certificates are attached to the relevant reports.
- (vii) With regards to the specialist studies to be undertaken, kindly note that the protocols only require studies to be undertaken where the verification confirms that the sensitivity is either high or very high. Should the sensitivity be confirmed to be low or medium, then a compliance statement is required.
- (viii) In addition to the above, the comments raised by the Mpumalanga Department of Agriculture, Rural Development, Land and Environmental Affairs in their letter dated 14 May 2024 must be adhered to and addressed.

(b) Listed Activities

- (i) According to the NPAES (2018), large portions of habitat in the study area have been mapped as Priority Focus Areas for protected area expansion. Similarly, the delineations presented in the Mpumalanga Protected Area Expansion indicate that large portions of the study area are designated as Priority 2 and Priority 3 areas for protected area expansion. Please ensure that all relevant GN R. 985 listed activities are applied for.
- (ii) Please ensure that all relevant listed activities are applied for, are specific and can be linked to the development activity or infrastructure as described in the project description.
- (iii) If the activities applied for in the application form differ from those mentioned in the final SR, an amended application form must be submitted.
- (iv) Please note that the Department's application form template has been amended and can be downloaded from the following link https://www.dffe.gov.za/documents/forms.

(c) Layout & Sensitivity Maps

- (i) The final SR must provide coordinate points for the proposed development site (note that if the site has numerous bend points, at each bend point coordinates must be provided) as well as the start, middle and end point of all linear activities.
- (ii) All preferred turbine positions must be clearly numbered. The turbine position numbers must be consistently used in all maps to be included in the reports (including specialist).
- (iii) Please provide a layout map which indicates the following:
 - a) The proposed position of the wind turbines, internal and external roads, substations, gate house and security, operational and maintenance buildings and the concrete batching plant;
 - b) All supporting onsite infrastructure such as laydown areas etc. (existing and proposed);
 - c) Battery Energy Storage System;
 - d) Connection routes (including pylon positions) to the distribution/transmission network;
 - e) All existing infrastructure on the site, especially railway lines and roads; and
 - f) Buildings, including accommodation.
- (iv) Please provide an environmental sensitivity map which indicates the following:
 - a) The location of sensitive environmental features identified on site, e.g. CBAs, protected areas, heritage sites, wetlands, drainage lines, nesting and roosting sites, etc. that will be affected by the facility and its associated infrastructure;

- b) Buffer areas; and
- c) All "no-go" areas.
- (v) The above map must be overlain with a sensitivity map and a cumulative map which shows neighbouring renewable energy developments and existing grid infrastructure.
- (vi) Google maps will not be accepted.

(d) Alternatives

- (i) Please provide a description of any identified alternatives for the proposed activity that are feasible and reasonable, including the advantages and disadvantages that the proposed activity or alternatives will have on the environment and on the community that may be affected by the activity as per Appendix 2 of GN R.982 of 2014 (as amended).
- (ii) Alternatively, you should submit written proof of an investigation and motivation if no reasonable or feasible alternatives exist in terms of Appendix 2.

(e) Public Participation Process

- (i) It is imperative that the relevant authorities are continuously involved throughout the environmental impact assessment process as the development property possibly falls within geographically designated areas in terms of numerous GN R. 985 Activities. Written comments must be obtained from the relevant authorities and submitted to this Department. In addition, a graphical representation of the proposed development within the respective geographical areas must be provided.

- (iii) Please ensure that comments from all relevant stakeholders are submitted to the Department with the final SR. This includes but is not limited to the Mpumalanga Department of Agriculture, Rural Development, Land and Environmental Affairs (MDARDLEA), the Mpumalanga Tourism and Parks Agency, the Msukaligwa Local Municipality, the Gert Sibande District Municipality, the Department of Water and Sanitation (DWS), the South African Heritage Resources Agency (SAHRA), BirdLife SA, the Department of Mineral Resources and Energy, and the Department of Forestry, Fisheries and the Environment: Directorate Biodiversity and Conservation
- (iv) Please ensure that all issues raised and comments received during the circulation of the draft SR from registered I&APs and organs of state which have jurisdiction.

- (iii) Should the appointed specialists specify contradicting recommendations, the EAP must clearly indicate the most reasonable recommendation and substantiate this with defendable reasons; and were necessary, include further expertise advice.
- (iv) Please ensure that all mitigation recommendations are in line with applicable and most recent guidelines.
- (v) It is further brought to your attention that Procedures for the Assessment and Minimum Criteria for Reporting on identified Environmental Themes in terms of Sections 24(5)(a) and (h) and 44 of the National Environmental Management Act, 1998, when applying for Environmental Authorisation, which were promulgated in Government Notice No. 320 of 20 March 2020 (i.e. "the Protocols"), and in Government Notice No. 1150 of 30 October 2020 (i.e. protocols for terrestrial plant and animal species), have come into effect. - (vi) The specialist reports must comply with Appendix 6 of the EIA Regulations, 2014, specifically, the specialist reports must include documentation to show expertise of the specialist to compile a specialist report including a curriculum vitae.
- (vii) As such, the Specialist Declaration of Interest forms must also indicate the scientific organisation registration/member number and status of registration/membership for each specialist.
- (viii) Please also ensure that the final SR includes the Site Verification Report as required by the relevant environmental themes and assessments.
- (ix) Please note further that the protocols, if applicable, require certain specialists' to be SACNASP registered. Please ensure that the relevant specialist certificates are attached to the relevant reports.

(g) Cumulative Assessment

(i) Should there be any other similar projects within a 30km radius of the proposed development site, the cumulative impact assessment for all identified and assessed impacts must be refined to indicate the following:

- a) Identified cumulative impacts must be clearly defined, and where possible the size of the identified impact must be quantified and indicated, i.e. hectares of cumulatively transformed land.
- b) Detailed process flow and proof must be provided, to indicate how the specialist's recommendations, mitigation measures and conclusions from the various similar developments in the area were taken into consideration in the assessment of cumulative impacts and when the conclusion and mitigation measures were drafted for this project.
- c) The cumulative impacts significance rating must also inform the need and desirability of the proposed development.
- d) A cumulative impact environmental statement on whether the proposed development must proceed.

(h) <u>General</u>

You are further reminded to comply with Regulation 21(1) of the NEMA EIA Regulations 2014, as amended, which states that:



Thank you for the opportunity to comment on the draft Environmental Scoping Report for the proposed Phefumula Emoyeni One Wind Energy Facility.

BirdLife South Africa supports the responsible development of renewable energy infrastructure. However, we are concerned that the location of the proposed facility(ies) may not be compatible with the desired state of the habitat as indicated in provincial and national conservation plans. The proposed development site falls within an Important Bird and Biodiversity Area (Amersfoort-Bethal-Carolina IBA) and includes threatened ecosystems, critical biodiversity areas, ecological support areas, and habitat for several threatened species.

The Amersfoort-Bethal-Carolina IBA hosts globally and regionally threatened species that are not found in similar abundance in other provinces. Several species are at risk of becoming extinct, some of which have be found at the proposed site (e.g., regionally threatened African Marsh Harrier (Endangered), Blue Crane (Near Threatened), Denham's Bustard (Vulnerable) and Cape Vulture (Endangered)). These high-elevation habitats are often used for breeding during the wet season. Given the relatively small remaining portion of untransformed Grasslands and Wetlands in the highveld of Mpumalanga, every step should be taken to safeguard what is left of these habitat types for biodiversity.

Data collection for impact assessment:

We support the Avifaunal Site Sensitivity Verification, which increased the sensitivity of the avifauna assessment from low to high sensitivity and the vulture species theme from medium to high sensitivity as obtained from the DFFE Screening Tool. Given this sensitivity within the Project Area of Influence, we note that just four seasons of avifaunal surveys will be conducted. We are concerned that this may not be adequate to robustly assess impacts and determine appropriate and feasible mitigation measures. Additional, surveys, targeted at addressing key risks and uncertainties may be required.

We are concerned that the wetlands at the site would offer stop-over sites for migrants transitioning through the landscape. Given the likely sensitivity avifauna using the area, we suggest that tracking data should be acquired from past studies/literature to identify which migrants are using this area and when. Alternatively, other methods (e.g., radar or tracking studies) should be included in the plan of study for impact assessment in order to assess the risk to migratory birds.

Please also refer to BirdLife South Africa's guidelines for <u>Cape Vulture</u> and <u>Black Harrier</u> and wind energy.

Are we correct that no night surveys were conducted? How will collision risk to nocturnal threatened species such as Grass Owl (Vulnerable) be assessed and mitigated?

We caution that while the updated list of priority species for wind farms compiled for the Avian Wind Farm Sensitivity Map (Ralston-Paton et al., 2017; Retief et al., 2012) is a useful starting point, it has limitations in the context of this region. The priority list published by BirdLife South Africa does not include most wetland species, and the sensitivity was weighted based on the overlap with wind energy facilities at the time. This did not include Mpumalanga. We therefore recommend that a site-specific list of priority species should be developed.

Impact assessment and mitigation

Concerning the identification of potential impacts, there are a few additional points that need to be considered. With the clearing of natural vegetation, there could be an increase in the occurrence of pioneer exotic species, especially invasives (Aquatic Systems, page 143 of 190). There could be a loss of ecological processes related to biodiversity loss such as pollination or biological control and loss of ecological drivers such as fire, since grasslands and wetlands need to burn (Terrestrial Biodiversity, page 148 of 190). During the construction phase of the turbines, there could also be a direct loss of avifauna, e.g., being hit by trucks. A possible mitigation measure would be implementing speed restrictions (Avifauna, page 150 of 190). Where will the water be sourced that will be used to spray the roads to control dust (Visual and Landscape, page 153 of 190)? Ecosystem services such as carbon sequestration, provisioning of clean water and tourism (especially if Botha's Lark (Endangered) is present in the broader area) have not been considered (Socio-Economic, page 156 of 190). And lastly the removal of vegetation will negatively affect the amount of carbon sequestered in the plants and soil (Climate Change, page 157 of 190).

We recognise that a more detailed strategy for identifying no-go zones and areas needing mitigation during the operational phase will be implemented in the next stage of EIA process. However, we want to stress that the proposed nest buffers are unlikely to adequately address biodiversity impacts. Nest buffers should be supplemented with a habitat-based approach. **BirdLife South Africa opposes largescale wind energy development in large, intact grassland habitats, especially if these areas are designated as Critical Biodiversity Areas.** These areas are crucial for supporting species like the Secretarybird (Endangered). For more details, please refer to the attached guidance note on development in Secretarybird habitat.

We note that shutdown on demand has been proposed as mitigation in some areas, and also if "any mortality of collision prone species of conservation concern (e.g. Verreaux's Eagle) is recorded shutdown on demand should **be considered**" (emphasis added). While we welcome shutdown on demand as a mitigation measure, we suggest that given the high avifaunal sensitivity of the site, and that the risk to some species (e.g. Cape Vultures) may not be limited to specific areas, a more proactive approach to shutdown on demand may be more appropriate. In our experience it can take many years before specialists' recommendations to for shutdown on demand are implemented (if at all). We also suggest that monitoring of fatalities should be implemented for the lifespan of the project and overseen by a bird specialist.

We suggest that the site sensitivity calls for more robust data collection and impact assessment. If development is deemed appropriate, precautionary (i.e. proactive), clear and enforceable operational phase mitigation measures are likely to be required to ensure impacts are within acceptable levels.

The application was assessed by using the following tools: Mpumalanga Biodiversity Sector Plan (MBSP, 2014 as updated 2022) land use guidelines, DFFE web-based sensitivity screening tool, Environmental legislation NEMA and EIA regulations 2014 as amended, Department of Water and Sanitation and Water Research Commission Guidelines on wetlands, the South African Heritage Resources Act and knowledge to assess development applications.

The sensitivity of the area, in which the Wind Energy Facility (WEF) is proposed was assessed according to MBSP terrestrial and freshwater assessments. In the MBSP, sensitivity areas are identified in terms of *Critical Biodiversity Areas* (CBAs) and *Ecological Support Areas* (ESAs). CBAs and ESAs are deemed to be necessary to ensure the protection of biodiversity, environmental sustainability and sustainable living and are to remain unaltered.

### Concerns

With reference to the assessment of your Draft Scoping Report the MTPA is concerned about the following issues raised with regards to the terms of reference for specialist studies to be done:

- 1. An alternative less sensitive development site to be found.
- 2. The ground truthing and on site studying of areas regarded as degraded or sensitive and suitable for potential wind turbines must be done considering that the cultivated lands might be feeding areas for many Species of Conservation Concern (SCC). The site sensitivity verification report must include the feeding areas for SCC.
- 3. The avoidance of large areas of critical biodiversity terrestrial and freshwater sensitivity areas in the preliminary project layout area is a large concern, especially in the southeastern part of the proposed area.
- 4. The threat of this WEF to the Important Bird Area and the current status of globally threatened bird species such as the Botha's lark is of a concern. The status of a list of the threatened bird species must be established.
- 5. The impact and extent of the connecting road network and associated grid connection and substations on the sensitive zones must be indicated. Wherever wetland and river crossings are needed, the EIA regulations must be followed.
- 6. The risk and threat of untimely fires caused by the infrastructure on the grasslands and SCC must be included in the risk studies.

Included in the MTPA's comments are the following discussion that illustrates the **need and desirability** of this proposal:

# Proliferation of renewable energy applications:

- Given the energy needs of the country, significant emphasis is being placed on the need to transition away from coal towards renewable energy. However, the urgency and desire to approve nearly all renewable energy applications needs to be put into perspective considering the incredible investment and proliferation of new renewable energy projects within Mpumalanga.
- The MTPA and DARDLEA are maintaining a database of renewable energy projects, which include those in the pre-application phase. We can confirm that 61 renewable energy projects have now been submitted within Mpumalanga. Just over 50% of these have been approved to date. 18 of these are for Wind Energy Farms, which together make up for 233 000 ha (which is about 3% of the province's surface area), and this amount is growing as the province is being inundated with renewable energy applications.
- The explosion of renewable energy applications does require careful consideration as to the likely impacts. There is no shortage of renewable energy projects within the Province and the Province has room to apply its mind and navigate this space carefully. The province has now over 300 000 ha of renewable energy applications, and the many more than are still to be submitted.

Mpumalanga Biodiversity Sector Plan (MBSP), Intact Grassland Patches and Important Bird Areas (IBAs).

- The project **footprint overlaps with a significant amount of Critical Biodiversity Areas** (CBA). 38% of the footprint area is identified as a CBA, of which 21% is in a CBA Irreplaceable area. Wind farms are not appropriate land uses within CBA areas.
- The whole of the proposed Phefumula Emoyeni wind farm falls within an Important Bird Area (IBA), which underscores the need to consider its implications on metapopulation dynamics and the need to avoid wind farms in "source" areas.
- 20% of the proposed wind farm is comprised of intact grassland patches. With only 51% of the grasslands remaining in a natural state, very little intact natural grasslands still occur in Mpumalanga.
- Intact grassland patches are areas larger than 100ha, with little or no gaps or edge effects. They
  were then prioritised according to their connectivity importance. These intact grasslands are "source"
  areas for avifaunal species where birth rates are expected to exceed death rates, and no wind farms
  should be placed anywhere near these intact grassland patches.
- The identification of actual avifaunal source areas may be difficult, but as these intact grassland patches occur within an Important Bird Area (IBA) where there are several nesting and roosting avifaunal species of conservation concern, it highlights their significance and our confidence in confirming these as "source" areas. The presence of these intact grassland patches, CBAs, and the IBAs, is probably the biggest concern that the MTPA may have about the proposed wind farm.
- Wind farms should not be placed in IBAs or intact grassland areas as these are important areas where avifauna should be allowed to thrive and then disperse to other areas.
- Already several wind farms have been approved in slightly less sensitive areas and in relatively close proximity, which would result in further impacts on bird species.
- Approval of the project in such a location could have far-reaching consequences for threatened bird species, potentially disrupting vital source areas critical for population sustainability.
- It is imperative to adopt a precautionary approach and prioritize the conservation of these essential habitats.

## Avifaunal concerns

- The presence of 34 priority bird species for wind energy developments were recorded within the footprint area.
- Of these, 12 were Species of Conservation Concern, of which four are nesting.
- A Martial Eagle nest (Endangered) occurs within footprint area. These are South Africa's largest eagles and travel over vast areas. They are also suspectable to collision with turbines and wind farms are of serious concern.
- Three Bald Ibis colonies (Vulnerable) occur within footprint area.
- A Secretary bird nest (Endangered) was found and assigned a 500 m buffer. Considering that the blade tip height alone may be up to 300 m high, this does not be sufficient as a recommended buffer.
- Birds are very mobile and with the proposed turbine height and blade lengths, the current proposed buffers seem inadequate.





- This raises particular concern as these birds may continuously collide with the blades of the wind turbines and the continuous loss of several of these long-lived birds every year may have a significant impact on population status.
- The MTPA has mapped all the dams in detail across Mpumalanga. There are 344 artificial water bodies within the footprint area that may be important for flamingos and other water-dependent birds.
- Buffers of 2km have been recommended for natural pans (not sure if they were mapped they do
  not appear on the avifaunal sensitivities map), however, should many of the 344 dams that occur
  within the footprint area also not be buffered? Many of these would provide similar habitat to that of
  pans.
- The avifaunal sensitivity map only considers four of the identified Species of Conservation Concern (SCC) and the heronry. Other field observations and the Birdlife SA species distribution models were not considered, potentially overlooking crucial habitat for vulnerable species like the Grass Owl.
- The MTPA have access to the Birdlife SA species distribution models and can confirm that:
  - Grass Owl (Vulnerable) have a strong probability of occurring on site although there is no indication as to whether any focused surveys were conducted to search for Grass Owls.
  - Black Harrier (and confirmed during avifaunal field work).
  - Botha's Lark may be present but not much is mentioned in report as to survey effort or whether any surveys for this species were specifically targeted during its breading season.
  - o Blue Crane (confirmed).
  - Grey Crowned Crane (not yet confirmed).
  - Rudd's Lark (although low probability).
  - Southern Bald Ibis (confirmed).
  - Secretary Bird (confirmed).
  - Verreaux Eagle (although low probability).
  - o Wattled Crane.
  - o White-bellied Bustard (confirmed).
  - White-winged Flufftail (low probability).
  - Yellow-breasted Pipit (low probability).

#### Site Sensitivity Verification

- The results of the Site Sensitivity Verification confirmed that:
  - The sensitivity for the Terrestrial biodiversity impact assessment as Very High/High in grassland and wetland habitat; and Low/Medium in secondary grasslands.
  - Aquatic Biodiversity Impact Assessment as High Sensitivity.
  - o Plant Species Assessment as Medium Sensitivity.
  - o Animal Species Assessment as High Sensitivity in areas of grassland and wetland habitat.
  - Bat Assessment as High Sensitivity.
  - Avifaunal Assessment as High Sensitivity.
- It is not clear whether the Site Ecological Importance methodology was applied according to the 2022 Species Environmental Assessment Guidelines. For example, if one searches through the

Terrestrial Biodiversity report, then "Site Ecological Importance" is only mentioned once under abbreviations and nowhere else.

 Similarly, for the avifaunal assessment, it is not clear how the specialist could go from "very high", "high", and "medium" sensitivity to an overall impact score of "moderate" pre-mitigation and "low" post mitigation. The report concludes that the proposed wind farm will have a **medium** impact on avifauna. I struggle to understand the reasoning given the high sensitivity.

## Limited biodiversity assessment

- The current draft scoping report is largely informed by desktop assessments. Understandably some data are currently being collected, such as with bat detectors and the additional avifaunal surveys, however the terrestrial biodiversity assessment was almost fully based on desktop assessment even though there was mention of field work conducted in December 2023 and January 2024.
- The status and knowledge of the biodiversity on the site is at times inadequate to inform the site verification or sensitivity analyses and limits our ability to accurately assess the project's ecological impact.

## Additional concerns

• Not all the infrastructure has been included on the map or addressed in terms of likely impact. The 60 km of road network will have an estimated impact of 108 ha.

## Recommendations

- Conduct comprehensive field surveys across the entire footprint area to assess terrestrial and aquatic biodiversity.
- Revise the avifaunal sensitivity map to incorporate all identified SCCs and utilize Birdlife species distribution models. Field observations and the species distribution models could have been incorporated into the avifaunal sensitivity map. It is of concern that only a few of the sensitive and threatened bird species recorded were included in the avifaunal sensitivities map.
- The current consolidated site sensitivity map of all 'no-go' areas (Figure 5-35) indicates little area for available for the wind farm. With more appropriate buffers, more field work, and all the associated infrastructure (such as roads), we cannot see how it would be possible to establish a wind farm within the footprint area.
- Increase buffer zones for endangered bird nesting sites to reflect their wider flight ranges relative to the height of the turbines.
- Consider alternative locations with less ecological sensitivity, especially considering the numerous renewable energy projects already approved in Mpumalanga.


## Conclusion

The proposed Phefumula Emoyeni One Energy Facility poses a significant threat to a Critical Biodiversity Areas, intact grassland patches, Important Bird areas, and the habitat of numerous threatened bird species. If we need to rely on the information presented to date, and the desktop assessments, then it is in our opinion that this project is fatally flawed. The anticipated impacts on biodiversity, particularly the avifauna, is too great to support this project. A more thorough ecological assessment and exploration of alternative locations is crucial before proceeding with this project.

The draft scoping report which was submitted by you in respect of the abovementioned application and received by the Department on 12 April 2024 has reference. The Department has considered the content of the report, and has the following comments:

- The proposed Phefumula Emoyeni One Wind Energy Facility is located in areas identified as CBA Irreplaceable, CBA Optimal, ESAs, Priority Focus Area, Freshwater Ecosystem Priority Areas and Threatened Ecosystems. Furthermore, the entire site falls within the Amersfoot-Bethal-Carolina Important Bird Area (IBA) and 18km west of the Chrissie Pans IBA.
- DARDLEA is concerned that the proposed location of the Phefumula Emoyeni One Wind Energy Facility (WEF) is therefore not compatible with the desired land use. The WEF and all associated infrastructure is not a land use, in accordance with the Mpumalanga Biodiversity Sector Plan (MBSP), that will support the inherent biodiversity values of CBAs.
- 3. Furthermore, <u>significant</u> areas of intact grasslands are located within the site footprint. DARDLEA does not support the development of WEFs (or any non-compatible land use) within intact grassland patches. The MBSP specifically incorporated climate change into spatial priorities through the prioritisation of the connectivity of remaining intact grassland patches in the province, as they provide habitat for species to thrive, and allow for their dispersal. Intact grasslands are crucial for supporting threatened avifauna.
- 4. The proposed Phefumula Emoyeni One WEF is located in an area comprising a high diversity of threatened bird species, a number of which are known to be vulnerable to wind turbine collisions. These include Botha's Lark, Blue Crane, Southern Bald Ibis colonies, Black Harrier, Blue Korhaan, Black-winged Pranticole, Secretary Bird (and nest), Martial Eagle (and nest), Denham's Bustard, Grass Owl, White-bellied Bustard and Lanner Falcon.



- 5. Jackal buzzard was also confirmed on site. It must be noted that this species is known to be particularly vulnerable to turbine collision, and it is understood that because of this, its threat status is likely to be moved from least concern to near threatened. Furthermore, night-flying greater and lesser flamingos were confirmed on site, and there is currently no known technology to mitigate for the collision of night flying birds.
- 6. We disagree with the assignment of impact significance as "medium" on Page 163 in respect of loss and fragmentation of fauna habitats during both construction and operation phases. Intact grasslands, as indicated above, are essential to ensure that species are able to thrive. Loss of intact grasslands directly impacts species' ability to breed and disperse. There is no clear justification or reasoning provided as to how significance score of "medium" was established (were the 2022 Species Assessment Guidelines followed?). The significance rating should therefore be "High".
- 7. Similarly, we disagree with the assignment of impact significance as "medium" on Page 165 in respect of all avifaunal impacts. The significance of the impact on Avifauna in terms of Habitat transformation, collision risk and electrocution of priority species is "High".
- 8. The plan of study for EIA must include and address the following:
  - 8.1 Terrestrial Biodiversity:
    - The impact of the loss of CBAs and intact grassland habitat in terms of metapopulation dynamics (ie. how the loss of source areas will impact areas of low quality habitat that cannot support a population of species on its own).
    - The Site Ecological Importance methodology, as per the requirements of the Species Environmental Assessment Guidelines, must be demonstrated to have been applied.
  - 8.2 Avifauna:
    - A <u>site-specific</u> list of priority avifaunal species for wind farms must be developed, which must include all wetland species.
    - The avifaunal sensitivity map needs to incorporate more than just the 4 nesting birds and the heronry.
    - The avifaunal sensitivity map must include all species of conservation concern.
    - BirdLife's species distribution models must be used and included in the avaifaunal sensitivity map.
    - Due to the sensitivity of the avifauna using the area, <u>more</u> than four seasons of avifaunal surveys is required to assess impacts and determine mitigation that is appropriate.
    - Due to the sensitivity of avifauna using the area, and the presence of pans and wetlands on and adjacent to the site, as well as the presence of night-flying birds, tracking data must be acquired to augment the 2D models used.
    - Surveys and tracking must be undertaken to determine the collision risks for nocturnal species.
    - The avifaunal assessment must account for the required turbine hub height and blade lengths in all surveys.
    - Nest buffers must be determined using a site-specific, habitat-based approach, and must account for technology design (ie. turbine hub height, blade length).
    - Buffers must be determined and assigned to all waterbodies on and adjacent to the site, including all pans, wetlands and dams.
    - As per the requirements in the avifauna section in the Species Environmental Assessment Guideline, existing guidance must be consulted where available and applicable to a certain development. All relevant BirdLife guidelines, guidance notes and position statements must therefore be consulted.
    - We are not in agreement with the avifauna specialist's conclusion that the significance of the impact on avifauna is "medium". The specialist must clearly demonstrate these findings.

- 9. On Pages 56 and 57 of the scoping report, you refer to the development of a biodiversity offset strategy to be included in the draft EIA due to "the very high sensitivities confirmed in terms of avifauna, the presence of primary grasslands and PES A/B wetlands on site, and the potential residual impacts and the recommendations received from DFFE". However according to the Biodiversity Offset Guideline, "The desired outcome of biodiversity offsets is to ensure that the cumulative impact of an authorised activity, or activities, and land and resource use change does not: result in the loss of irreplaceable biodiversity or jeopardise the ability to meet biodiversity targets; lead to any ecosystem with a threat status of Vulnerable or Least Concern becoming Endangered; or any Endangered ecosystem becoming Critically Endangered; or cause an irreversible decline in the conservation status of species and the presence of special habitats; or cause a significant loss in ecosystem services". A biodiversity offset cannot therefore cater for the loss of irreversible CBAs or intact grasslands, nor can it compensate for the loss of endangered bird or bat species.
- 11. The draft layout plan (Figure 5.37) has proposed the location of 135 wind turbines, some of which are in sensitive areas. No associated infrastructure (ie. Substations, BESS and roads) is included in the projected layout. It is understood that substations and BESS will comprise 45ha, and roads will comprise 60km. All infrastructure must be included in the layout, and all associated impacts must be analysed.
- 12. Due to the high sensitivity of the agricultural theme, the Department of Agriculture Land Reform and Rural Development (DALRRD) must be identified as an interested and affected party.
- 13. We are concerned that the proposed development site is not suitable for the development of wind energy infrastructure, and that it may not be in line with the National Environmental Management Principle that requires that sustainable development consider the application of a risk-averse and cautious approach that takes into account the limits of current knowledge about the consequences of decisions and actions; or the principle that specifically requires that a development must be socially, environmentally and economically sustainable, as the disturbance of 'ecosystems' and loss of biological diversity cannot be avoided, minimized or remedied.



Mashala Hendrina Coal (Pty) ("MHC") Ltd has been identified as an Interested and Affected Party for the Phefumula Emoyeni One (Pty) Ltd proposed wind facility due to the fact that the aforementioned project overlaps with MHC's Gugulethu Colliery, mining right reference number MP 30/5/1/2/2/365 MR.

MHC would like it placed on record that Gugulethu Colliery's mining right was granted in 2014, and the colliery is currently operational. At present, opencast mining, and associating processing activities, are taking place on site, with future expansion into underground operations in the next five (5) years. Some of the activities are on properties owned by the Group and some are on properties where MHC has the lawful use of the surface rights.

As a result of the nature of the opencast activities, co-existence is therefore not possible.

The following is in response to the documentation received on 12 April 2024 respectively:

1. Comments on the Draft Scoping Report



- 1.1 The draft Scoping Report did not provide the Department of Forest, Fisheries and Environment (DFFE) reference number, only internal reference numbers were provided.
- 2.1 Listed activities that are triggered are required to have their own heading, as per the National Environmental Management Act (NEMA) Regulations GNR 982 (as amended) Section 2 (1) (d) (i), this is not within the report. The listed activities have been included in the policy and legislative context section; the listed activities need to be in their own section.
- 3.1 Alternatives not assessed appropriately as per the NEMA Regulations GNR 982 (as amended) Section 2 (1) (g) (v). The alternatives have not been assessed in terms of nature, significance, consequence, extent, duration and probability of such identified impacts, including the degree to which these impacts can be reversed, may cause irreplaceable loss of resources and can be avoided, managed or mitigated.
- 4.1 Positive and negative impacts alternatives will have will have on the environment and on the community that may be affected focusing on the geographical, physical, biological, social, economic, heritage and cultural aspects were not provided in the report, only the overall summary of all impacts were provided in the draft Scoping Report. This is required as per NEMA Regulations GNR 982 (as amended) Section 2 (1) (g) (vii).
- 5.1 The draft Scoping Report did not include a no-go option as an alternative, Section 24(4)(b)(i) of NEMA (as amended), provides that an investigation must be undertaken of the potential consequences or impacts of the alternatives to the activity on the environment and assessment of the significance of those potential consequences or impacts, including the option of *not implementing the activity*.
- 6.1 The undertaking under oath section within the draft Scoping Report, as per NEMA Regulations GNR 982 (as amended) Section 2 (1) (i) (i-iii), is missing key points:
  - the correctness of the information provided in the report;
  - the inclusion of comments and inputs from stakeholders and interested and affected parties; and;
  - any information provided by the EAP to interested and affected parties and any responses by the EAP to comments or inputs made by interested or affected parties.
- 7.1 NEMA Regulations GNR 982 (as amended) Section 2 (1) (k) and (l) from the draft Scoping Report is not included, even if this section is not applicable it should be included.
- 8.1 NEMA Regulations GNR 982 (as amended) Section 2 (1) (I) states that "any other matter required in terms of section 24(4)(a) and (b) of the Act"- Section 24(4)(b)(i) of NEMA (as amended), provides that an investigation must be undertaken of the potential consequences or impacts of the alternatives to the activity on the environment and assessment of the



significance of those potential consequences or impacts, including the option of not implementing the activity. As mentioned previously, the alternatives were not assessed and the no-go alternative was not assessed.

9.1 NEMA Regulations GNR 982 (as amended) Section 2 (1) (h) (ix) states "identify suitable measures to avoid, reverse, mitigate or manage identified impacts and to determine the extent of the residual risks that need to be managed and monitored". This was not made clear within the draft Scoping Report. Minimal monitoring was included in Section 6.1 (Potential Impacts) of the draft Scoping Report. It is an Environmental Assessment Practitioner's duty, during the Scoping Phase, to assess which impacts would require managing and monitoring, even on a high level. The monitoring mentioned in the Section 6.1 is insufficient.

Based on the aforementioned comments, the Scoping Report needs to be revised to include the necessary sections.

MHC reserve the right to comment further on the application should any new information become available to us that we consider to be of importance.
